

## WORKING CONDITIONS

National Commercial Agreement 2002-2004

1. **AUDITION RECALL:** All Performers sign audition sign-in sheets at audition call. Audition recalls are paid at \$25 per callback.
2. **CONTRACTS:** Performers engaged at above-minimum fees may demand and receive a copy of their contract 24 hours prior to session. Minimum contracts shall be available to Performers at least 15 minutes prior to session.
3. **MEAL PERIOD:** A 1-hour meal break must commence on the 6<sup>th</sup> hour from 1<sup>st</sup> call provided a 'substantial snack' is served prior to the 5<sup>th</sup> hour. Meal penalty is \$60.00/\$61.50 for all categories.
4. **POSTPONEMENT:** If less than 48 hours notice is given, Performers receive full fee.
5. **CANCELLATION OF COMMERCIAL:**  
**TV:** less than 4 days notice, Performers receive full fee.  
**Radio:** less than 48 hours notice, Performers receive full fee.
6. **CANCELLATION OF WORK DAY:** Cancelled days must be paid in full.
7. **MINORS:** a) All auditions must be after school hours.  
b) Under the age of 12, no Additional Work Time or Overtime. Performers from 12 to 15 years of age, 2 hours Additional Work Time permitted with written consent of Parents.
8. **DORMANCY FEE:** Due within 26 weeks of non-use.
9. **PAYMENT TO PERFORMER:** Session Payments must be made within 15 working days after performance. Residual Payments must be made within 20 working days of First Air Date. 4% will be deducted from all Performer cheques. 1.75% work dues will be deducted from Full member cheques.
