**ACKNOWLEDGMENT AND APPOINTMENT**

I acknowledge that I am a **performer** and that to the best of my knowledge and belief, by virtue of my performance(s) in **eligible sound recordings**, I have a right to receive remuneration under the Copyright Act, in particular, but without limiting the generality of the foregoing, pursuant to the provisions of sections 15, 19, 30.8 and 30.9, as well as s.81 of the said Act (hereinafter referred to as Rights of Remuneration).

I hereby appoint the **ACTRA Performers' Rights Society** (the Society) to be my sole, plenary and exclusive agent in respect of the enforcement of any of my Rights of Remuneration, whether currently in force or to be enacted in the future. In particular the Society shall be authorized to take all actions it deems necessary and expedient in respect of the filing and defending of tariffs under the Copyright Act, with the Copyright Board or in any court of law, implementing and administering a licensing scheme for Rights of Remuneration in accordance with approved tariffs, collecting all monies on my behalf and distributing same in accordance with the Society Policies and Rules and Regulations, as determined from time to time.

This appointment shall be valid, subsisting and irrevocable by me, for an initial term of five (5) years, said term shall run from the date of execution hereof. Unless I provide a written revocation of this appointment within the last three (3) months of the five (5) year term, (or any subsequent two (2) year term of renewal) this appointment shall be automatically renewed for an additional term of two (2) years.

Any reference to an Act of Parliament referred to by name will mean that Act in force at the material time and includes any amendment or any successor Act which replaces it. The parties intend that the proper law governing the interpretation and implementation of this agreement is the law prevailing from time to time in Canada. This agreement shall also be deemed to be valid and enforceable in accordance with the law of any other jurisdiction.
